WHEREAS, on or about November 10, 2021, the Borough of Closter adopted an Ordinance appropriating a sum not to exceed \$118,000.00 from Open Space, Recreation, Farmland, and Historic Preservation Trust Fund for Park, Farmland, and Historic Preservation Improvements; and

WHEREAS, due to an error in said Ordinance Section 1 of same needs to be amended to increase the appropriation from \$118,000.00 to \$123,000.00, and similarly the appropriation referenced in Exhibit A Construction of a Dog Park and Fencing needs to be increased from \$21,000.00 to \$26,000.00.

NOW, THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Closter, County of Bergen, State of New Jersey that Section 1 of Ordinance No.: 2021:1285 is hereby amended to increase the sum of \$118,000.00 to \$123,000.00; and

BOROUGH OF CLOSTER ORDINANCE NO. #2022-1292

CALENDAR YEAR 2022 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Borough Council of the Borough of Closter in the County of Bergen finds it advisable and necessary to increase its CY 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Borough Council hereby determines that a 1% increase in the budget for said year, amounting to \$127,677 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Closter, in the County of Bergen, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2022 budget year, the final appropriations of the Borough of Closter shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$446,869, and that the CY 2022 municipal budget for the Borough of Closter be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

TAX REIMBURSEMENT CERTIFICATION

WHEREAS, whenever a municipality operates a municipal service system for solid waste collection, or provides for regular solid waste collection service under a contract awarded pursuant to the "Local Public Contracts Law", the amount of grant monies received by the municipality shall not be less than the annual amount of recycling tax paid by the municipality except that all grant moneys received by the municipality shall be expended only for its recycling program; and

NOW, THEREFORE, BE IT RESOLVED, the Borough of Closter hereby certifies a submission of expenditure for taxes paid pursuant to P.L. 2007, Chapter 311, in 2021 in the amount of \$9,835.74. Documentation supporting this submission is available at the Closter Department of Public Works, 130 Ruckman Road, Closter, New Jersey 07624 and shall be maintained for no less than five years from this date.

WHEREAS, a resolution authorizing this municipality to apply for such tonnage grants will memorialize the commitment of this municipality to recycling and indicate the assent of the Mayor and Council to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and

WHEREAS, such a resolution should designate the individual authorized to ensure that the application is properly completed and timely filed;

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Closter hereby endorses the submission of a 2021 Municipal Recycling Tonnage Grant Application to the New Jersey Department of Environmental Protection, Office of Recycling, and designates Carole Dacey to ensure that the said Application is properly filed; and

WHEREAS, the annual audit by the Borough of Closter's auditing firm, Lerch, Vinci & Higgins, LLP, has identified the need for the Borough of Closter to engage the professional services of a certified actuarial consulting firm; and

WHEREAS, the services of an actuary consultant are required to review the postretirement benefits, valuation and other services as requested by the Borough's Auditors as the Borough is required to measure and recognize the long-term actuarial value of the financial obligations associated with post-retirement benefits to its workers and their families that extend into retirement, inclusive of medical, prescription drug, dental and vision coverage; and,

WHEREAS, the Borough Administrator authorized the placement of a Request for Proposal to be posted on the Borough's website with a return date of March 30, 2022, and;

WHEREAS, the Borough received four proposals and;

WHEREAS, the consulting firm of Cirkiel Actuarial Consulting LLC, 3 Highland Terrace, Upper Montclair, New Jersey, 07043, provided the lowest responsible proposal for the actuarial services; and,

WHEREAS, Cirkiel Actuarial Consulting, LLC. have provided a written proposal for the services required to address the recommendations from the Borough's auditors at a flat fee of \$3,500.00 under the GASB 75 calculation of actuarial obligations; and,
