WHEREAS, the New Jersey air Housing Act, N.J.S.A. 52-27D-301 et seq., (the "Fair Housing Act") recognizes and encourages municipalities to cooperate with and work together to achieve the goal of the Fair Housing Act; and

WHEREAS, the Borough of Closter is desirous that the Borough of Paramus administer the Borough of Closter's Affordable Housing Rental Program; and

WHEREAS, the Borough of Paramus and the Borough of Closter desire to enter into an agreement pursuant to which the Borough of Paramus will provide administrative services for the Borough of Closter's Affordable Housing Rental Program, which services will include serving as the administrative agent for the Borough of Closter's Affordable Housing Program and the management and oversight of the renting of existing affordable housing units located in the Borough of Closter; and

WHEREAS, it is in the best interests of the Borough of Closter to enter into the Interlocal Services Agreement with the Borough of Paramus as described above and the supplemental agreement between the Borough of Closter and the Paramus' authorized subcontractor Paramus Affordable Housing Corp.

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Borough of Closter authorizes the Mayor and Borough Clerk to execute and deliver the Interlocal Services Agreement as set forth in this resolution, and

BE IT FURTHER RESOLVED, that the Governing Body of the Borough of Closter hereby authorizes the Mayor and Borough Clerk to execute and deliver the agreement between the Borough of Closter and Paramus Affordable Housing Corp., as authorized subcontractor for the Borough of Paramus.
