3. <u>Approval of Ordinance 2020-1 "An Ordinance Regulating Massage Establishments,</u> Bodywork and Somatic Massage and Non-Certified Practitioners."

4. <u>Introduction resolution of permanent position for the Registrar/ Licensing Official/ Board Secretary and recommendation of hiring Jin Bae as Registered Environmental Health Specialist once she is released from Mid-Bergen Regional Health Commission.</u>

Board of Health Members agrees that Jin Bae has been performing the duties as temporary Registrar/ Licensing Official/ Board Secretary well, recommend making the appointment permanent.
