- a. MAIL LIST OF JUNE 24, 2022 Councilwoman Latner spoke about Item 5 and was told that the sign for the Lustron house was on the agenda for the Open Space ordinance this evening.
- b. MAIL LIST OF JULY 1, 2022 The Mayor and Councilman Yammarino spoke about the energy tax receipts. The administrator explained that he will meet with the CFO and ask about the status. Councilwoman Amitai asked about the UCC annual report and whether the new Construction Officer would be responsible for it. She was told it was his responsibility and asked the administrator to follow up with him
- c. MAIL LIST OF JULY 8, 2022 Councilwoman Chung spoke about number 4 and said she felt the approval for the event on August 2 should be given. It will be taken care of at the regular meeting. Councilwoman Amitai said she hoped it could be publicized. Councilman Devlin asked whether the cell tower would be left (Item #1). Because Sprint and T-Mobile have merged, the Sprint site will be removed, but another company may replace them.
- 5. **ORDINANCES** The administrator explained that the ordinances were passed in December and that the soft costs were the only change at this time. The money will be re-allocated within the ordinance. There will be a public hearing at the regular session.

6. REVIEW AND DISCUSSION OF CONSENT AGENDA ITEMS FROM REGULAR MEETING

(Refer to the Regular Meeting Agenda of July 13, 2022) The Mayor asked that a motion be added to appoint Larry Kleiner as conflict counsel for the ethics board. It will be added at the regular meeting. Councilman Devlin said that he didn't know enough about him at this time. Councilman Devlin asked about the resolution canceling the dog park and asked if the money had to be returned. The administrator explained that the money was never actually received because no work was actually done. There is no alternate site at this time. The fencing that was part of the dog park cannot be paid for by the grant because the grant was for the dog park. Councilwoman Witko asked about the possibility of putting the dog park in the space next to the gas station. The administrator explained that the impetus for the dog park was that the park needed an upgrade, but the community did not want a dog park in that location and there is no great outcry for a dog park. As there is no dog park at this time no money will be received for this particular grant. Councilwoman Chung asked what the residential repairs listed on the Open Space ordinance entailed and was told they were for the outside of the house and the grounds at the MacBain Farm.

7. **PROFESSIONAL REPORTS**

A. <u>BOROUGH ENGINEER</u>

REPORT The Piermont Road/Vervalen Street intersection project has no update. The 1) engineer suggested it might help if the borough writes a letter to the county. Re the Swim Club, letter was received from the DEP (after almost 5 years) and they want the footprint of the study area to be expanded. The engineer will use a company that does such studies and will bring a proposal. The Blanch Avenue Bridge: A final invoice is now able to be completed. The engineer suggested that the administrator put together a list of costs to ensure that the costs are split evenly with Norwood. Re; Railroad Avenue: The road was milled and was supposed to be paved last Saturday; due to a problem at the plant it will be paved this Saturday. The other roads are going well. Fuel has gone up considerably. The DOT has an asphalt price adjustment item to help with this cost. Thus the cost of asphalt has gone way up. Re: Colgate Street: NRCS has approved the plans, and the plans can now be submitted. NRCS marked it as an emergency. The 2023 road paving grant application has been submitted to the DOT. Councilwoman Amitai asked for an idea of how much money has been invested into the swim club area. The engineer explained that about \$50,000 have been invested into testing but none on construction. As long as the work stays within Open Space, 75% of the costs will be reimbursed. Discussion,

8. **REPORTS**

A. BOROUGH ADMINISTRATOR

REPORT Grants: Still waiting for official word on the Lewis Street ADA bathroom. The refrigerators have been installed in the Senior Center. \$10,000 from AARP has been granted for the downtown pocket park. The CIC will be working on the project. The Interlocal agreement with Paramus is up and running. Many meetings have been taking place with council people and residents about flooding. The administrator will attend an online meeting with the comptroller's office to ensure that Closter is in compliance with the new regulations. The comptroller's office will meet with the Closter staff in late July. Anyone signing off on purchase orders should go to the meeting. Councilman Devlin asked

whether there was any progress with the trees behind the library. The administrator said that John McCaffrey may give a proposal to take down some of the trees and then use the wood.

C. MAYOR

- 1) REPORT On a sad note, Jim Ottinger's mother passed away. The Mayor asked for a moment of silence. There were 16 new COVID cases in the last week. There have been no related deaths. The Mayor will start reporting on statistics for the ambulance and Fire Department.
- 9. **OLD BUSINESS** Councilwoman Amitai asked whether the bamboo situation was under control and was told that the reimbursement check was on the bills list for tonight and that no new issues had been reported.
- 10. NEW BUSINESS Councilwoman Amitai reported that Pop-up performances have been approved at Closter Plaza. A lovely, professional opera singer sang the National Anthem at a game this evening and will sing at another. A resident would like to do a piece of permanent art at Ruckman. The Recreation chair likes the idea. Councilwoman Amitai will meet with the resident about details. The Mayors Art committee has been scheduling events at the plaza and will share the details with the Council. About the tree lighting, the committee would like to light the four trees in front of the Borough Hall lit with tiny white lights. She is getting a quote. An offer to draw a mural in the borough has been received. She asked everyone to think of a location. She has spoken with Don Farrell, who would like a lone horseman as part of the mural, to reflect part of the history. Councilwoman Witko spoke about the HR meeting, at which live meetings were discussed. Discussion. The administrator will talk to the IT department about options for Zoom access for the public while the ideal equipment is on order. A decision will be made at the next meeting.

He asked for an update on the RFP for MacBain and was told that it would be coming up in October. He asked (re the dog park) about the property near the Tenakill bridge and was told that the Recreation Commission was looking at various sites. He asked about the Trautwein Farm as a location for a farm and was told it was part of the COAH settlement. He asked for clarification on why the Recreation funds were going directly to the Coaches' Association. The attorney will look into this. Jean Stella said that she was happy something was done at the corner of High and Closter Dock but feels that more may still need to be done, perhaps painting the "Stop Ahead" sign. Maybe adding a "slow" sign at the corner. She had thought that the RFP was going to be posted during the summer and the proposals considered in October. She said that the MacBain house is a designated historic house and needs to be repaired in a specific way, thus the \$18,000 requested. She hopes the Lustron house can get a sign and would like meetings to be able to be held in a hybrid fashion. The MacBain Farm is going really well, and there is a lot to pick. Linda Albelli is doing a lot of good work at the Senior Center. The meeting was closed to the public. Councilwoman Amitai put out the word that a new picture of the Lustron House on the county historic homes website would be helpful.
