#### 4. **PRESENTATION**

Environmental Commission – Sustainable Jersey. Paul Yarin spoke about the process and virtues of pursuing Sustainable Jersey certification. He asked the Council for their support. A Green Team would need to be created. Steve Isaacson asked whether an environmental master plan would be helpful. Discussion. Councilman Devlin spoke about the need to make sure the Council is supportive. Different Council members spoke and voiced their support. Councilman Yammarino asked for material to review.

John and James McCaffrey joined the meeting (on the phone) for a hearing on the tree fines for 375 Blanch Avenue, Closter. They were both sworn in. Bill Fuchs described that he was called to the property because someone claimed that trees were being taken down without a permit and levied a total fine of \$6143.30. John McCaffrey spoke about being in town since 1960 and being curator of MacBain Farm for 23 years. He spoke about closing on the property in December and that most of the trees were transplanted but that the 6 trees in question were diseased, dead, and compromised. He said they were working to clean up the property. He said that 2 trees were hit by a town tree and completely snapped off and described the other 4 trees. He stated that he did not know that a permit was required but would have gotten one if he had known. He said that they were willing to pay the permit fees and planned to replace and plants that were removed. They were on a mission to fix up the property and make the property a master garden. He asked for relief on the fines. The Mayor thanked him for cleaning up the property and said that the Mayor and Council would consider the request.

Councilman Devlin asked about line items on the tree budget. The Administrator explained that money was being taken from the tree fund for the Shade Tree Commission. Councilman Devlin asked for assurance that Shade Tree money would be able to be spent appropriately this year. He also asked about the garbage contract. The Administrator explained that nothing was changing on the street pickup side. Councilwoman Amitai said that there is a Welcome to Closter sign with no landscaping. She said that her organization would plant flowers and just needs the DPW to water it. The Mayor said there could be a resolution on the next agenda. The Administrator just asked her to review the design with the DPW superintendent. Councilman Yammarino explained that many other departments were having their budgets reduced a bit to put money toward the Ambulance Corps. Councilwoman Chung spoke a bit about the language in the recycling contract that was a bit confusing and asked the Borough attorney to look at it.

Gary Vinci joined the call to discuss the budget. The public hearing on the budget (which has a total increase of just under \$700,000) is on the regular meeting agenda. He said the Borough is in excellent financial condition. The budget amendment will include the grants received and appropriations. It is also on the agenda. Discussion with the Council about the valuation of Closter and the impact of the American Rescue Act. Mr. Vinci left the meeting.

# 9. **REPORTS**

#### 10. **COMMITTEE REPORTS**

- a. FINANCE & TECHNOLOGY YAMMARINO (DEVLIN/WITKO) Councilman Yammarino shared that he is not completely happy with the budget but that it is moving forward. The summer concert series continues. Summer Recreation starts this Monday. There are concerns that many people have not filed their Financial Disclosure Statements. The Council is 100% compliant. A list will be compiled and addressed.
- b. PUBLIC SAFETY LATNER (CHUNG/YAMMARINO) Councilwoman Latner stated Ivan fell off the ladder cutting limbs at the Library. Melissa Chalmer is moving away. Someone is taking up all of the work she did. Today is the Northern Valley High School graduation. On behalf of Don Farrell, is there a schedule for removing the limbs near the Nature Center? The answer is that there are many trees that need to be cleared because of the ash borer problem. May

be these could be put on a list. Don Farrell also asked whether there could be an automated call about car thefts and things like that. The Police Chief said that possibly the Swiftreach system could be used but that it also shakes people up and was a Council decision. Councilwoman Chung asked if there was any way to protect the trees. Discussion.

- c. PUBLIC WORKS CHUNG (AMITAI/WITKO) There had been complaints from residents on Meadows after a large storm. A team went to the residents to reassure them that the situation is on the list for remediation. Tomorrow she, the Administrator, and Engineer will visit a resident on Wendy Lane.
- d. ORDINANCES DEVLIN (AMITAI/LATNER) The Ordinance Committee discussed parking on Bogert and Hickory, raffles, vacant houses, electric vehicles, tree mitigation. The Shade Tree Commission received a grant for a Shade Tree Inventory. The Environmental Commission received a grant for Buzzoni Farm. The website has been updated.
- e. HUMAN RESOURCES WITKO (LATNER/YAMMARINO) Several Council members attended a luncheon at the Hillside School. The Fire Department hours and calls were reviewed.
- f. LAND USE AND CONSTRUCTION AMITAI (CHUNG/DEVLIN) Sophie Heymann has fallen and is still in the hospital, but her spirits are good and is attending zoom meetings. She has a video tape for Lustron House that she would like on the website. She said the Farm Committee is doing great! The Seniors have an active schedule. The Lions Club wants to do a Duck Derby fundraiser. In order to do that, they will need the DPW to remove a small tree that has fallen into the waterway at the park. The CIP is trying to determine the best way to welcome newcomers. The first event of the Mayor's Council on the Arts was well received. Phase 2 is now in process—planning on pop-up events of all sorts at several locations. They are calling on people to perform. A lot of money was raised for the Ed Rogan Scholarship. The electric car show has been canceled. Paul Weisman reported that the Farm officially opened on June 19 and looks quite good.
- g. MAYOR'S LIAISON REPORT He attended the Ambulance Corps meeting last night; they are having difficulty with their fundraising. He encouraged people to spread the word.

#### 11. **PROFESSIONAL REPORTS**

- a. BOROUGH ENGINEER Piermont Road/Vervalen Road: He has emailed the County a few times without much response, but it is on their list. Closter Swim Club: There is debate with the EPA about the way the contamination in the wetland is being handled in the absence of direct guidelines. The final invoice for the Blanch Avenue Bridge has not yet been received. The Road program is underway. The Local Aid Grant is on the agenda for today. The LFIF grant: the job is underway. The next is to remove the spur and resurface it, maybe by mid-July. Discussion about the gray areas surrounding the wetland contamination, it is a lower-level contamination, and remediating it could do more damage to the wetlands than is warranted. Thus, a waiver is being sought.
- b. POLICE CHIEF Everything went well with the moving-up ceremony at the school. National Night out is August 2. Operation Chill in conjunction with 7-11 is underway. A meeting has been held concerning the Police Headquarters. Councilman Devlin asked if there would be overtime for the National Night Out. The Chief said that the officers would receive comp time not overtime. Councilwoman Amitai asked about a Safe Streets and Roads grant and whether it concerned High Street. The Chief will read the application again but does not believe it will apply to High Street.
- c. MAYOR An educational forum had been planned at the Senior Center concerning legislation affecting public schools in NJ. It will take place at 7:00pm on the 29<sup>th</sup>. He asked for the support of the Council. Councilwoman Amitai said that she had sent a request for the use of the Senior Center. The Mayor believes that he worked it out.

#### 12. OLD BUSINESS

- a. McCaffrey Tree Violations (addressed earlier in the meeting).
- 13. <u>NEW BUSINESS</u> The trees affected by the ash borers need to be addressed. The Administrator will speak to the Borough tree expert.
- 14. OPEN MEETING FOR PUBLIC COMMENTS (5 MINUTE LIMIT) Steve Isaacson reminded everyone that the original Closter Cleanup came from the Green Team, that an Environmental component to the Master Plan was important, that Ken's Tree Care should cut down the 40 trees as part of the deal for running their business off town property. He asked if there was a response to the RFQ for the farm and was told that it hadn't gone out yet. He said that on Walker there was clearcutting and that to stop the flooding you have to stop the clearcutting. He said that instead of money John McCaffrey should give plants.

Joe Bianco said that he felt there would be requests for higher buildings in town, that he supports sustainability, and that people can contact him.

Ross Herbert thanked the Mayor and Council for their support of the Ambulance Corps. The Mayor thanked him.

Ms. Gleason asked about the senior transportation van. Her mother was using it and now was told that it holds only three people and can only be used for medical needs. Councilwoman Witko responded. It is primarily for medical transportation it is shared with two other towns and is used a lot. This van is temporary; a new one is on order. There is no solution at this time. It can be taken up again when there is more information. Councilwoman Amitai said that she knows of at least two other people who go daily to the JCC. Maybe they can all travel together.
