ORDINANCE NO. 2022-1308: AN ORDINANCE APPROPRIATING A SUM OF \$178,000 WITH OPTION A OR \$210,000 WITH OPTION B FROM OPEN SPACE, RECREATION, FARMLAND, AND HISTORIC PRESERVATION TRUST FUND FOR PARK, FARMLAND, AND HISTORIC PRESERVATION IMPROVEMENTS
