Mr. Chagaris spoke of prepared resolution which was e-mailed to members on October 6<sup>th</sup>, 2009. Motion was made by Mayor Heymann and seconded by Dr. Maddaloni to accept prepared resolution. Councilwoman Amitai asked for clarification of vote. Mr. Chagaris responded. Everyone who originally voted on application in January 2009 was in agreement. (This included Mayor Heymann, Councilwoman Amitai, Dr. Maddaloni, Ms. Isacoff, Mr. Lignos, Dr. Friedman, and Mr. Ouzoonian.) Mr. DeNicola spoke of the revised plans received. Mr. Watkins also spoke of the proposed revisions. Mayor Heymann stated that the property needed to be bid out prior to the subdivision. Mr. Chagaris stated that perfection would be conditional. Dr. Maddaloni asked for additional clarification. Mr. Chagaris responded. Ms. Isacoff asked for basis of perfection due to many conditions. Mr. Chagaris stated that the Mayor and council would be unable to take the next step without prior perfection approval from the planning board. Motion was made by Dr. Friedman and seconded by Dr. Maddaloni to perfect application (with mentioned stipulations). Everyone present (with the exception of Mr. Sinowitz and Mr. Barretta who abstained) agreed.

Mayor Heymann spoke of the shade tree's involvement. Councilwoman Amitai spoke of the 300 year anniversary of Closter which will take place in 2010. Mayor Heymann spoke on same. Mr. Ouzoonian spoke on behalf of the historic commission. He spoke specifically of the recent nominated areas. Mr. Lignos stated item should be put on next Work Session Meeting.
