Block 1314, Lot 1& 2 248 Closter Dock Road Application # P-2016-09 Applicant: Wally's Bagels Attorney: Mr. Geneslaw, Esq.

Mr. Pialtos recused himself from this application. Councilwoman Amitai took over chairing. Mr. King also stepped down from the dais & Mr. Chagaris sat at dais for purpose of this application. Mr. Geneslaw spoke of background of this application, commenting on revisions as per court negotiations. He stated there was no need for additional testimony. Mr. Chagaris commented on same, stating that the public (within 200 feet of site) have been noticed accordingly. Mr. Pialtos asked for clarification regarding revised seating. Mr. Chagaris responded, speaking of enforcement. He also stated that proposed seating was consistent with the Borough ordinance. There were no comments from the public at this time. Motion was made by Ms. Brewster & seconded

by Mayor Glidden to approve "amended" application/resolution. All present were in favor of approval with the exception of Ms. Corso who wasn't qualified to vote.

Mr. Chagaris stated that although the AME Zion church & Chase/Closter Market Place had a settled regarding litigation, at this point the Church has decided to resume the case.

Councilwoman Amitai spoke of the dismissal of the case regarding Heidenberg Plaza ADA parking.

Motion was made by Councilwoman Amitai & seconded by Mayor Glidden to adjourn meeting. Meeting was adjourned at 8:40PM.
