Demolition Permit Checklist

- BUILDING PERMIT APPLICATION WITH PROPERTY TAX RECORD CARD FOR EXISTING BUILDING TO BE DEMOLISHED;
NOTE: BERGEN COUNTY UTILITIES AUTHORITY SEWER CONNECTION APPROVAL IS REQUIRED IF EXISTING BUILDING TO BE DEMOLISHED CONTAINS (2) BEDROOMS OR LESS, SUBJECT PROPERTY WILL HAVE CHANGE OF USE AND / OR IT IS VACANT / UNDEVELOPED LAND;
- PLUMBING PERMIT APPLICATION (SEWER CAP INSTALLATION);
- UTILITY DISCONNECTIONS (GAS, WATER AND ELECTRIC);
- HEALTH DEPARTMENT APPROVAL (PEST CONTROL AND PORTABLE TOILET);
- ASBESTOS HAZARD ABATEMENT CERTIFICATION;
- NOTIFICATION TO ALL ADJOINING PROPERTIES VIA CERTIFIED MAIL (RETURN RECEIPT IS NOT REQUIRED);
- SEWER CONNECTION MARK-OUT BY DEPARTMENT OF PUBLIC WORKS (EMAIL CONFIRMATION IS REQUIRED);
- EXISTING SURVEY HIGHLIGHTING ALL STRUCTURES TO BE DEMOLISHED;
- TREE REMOVAL PERMIT;
- BERGEN COUNTY SOIL CONSERVATION DISTRICT APPROVAL;

SITE INSPECTIONS WILL BE CONDUCTED PRIOR TO THE ISSUANCE OF DEMOLITION PERMITS (AS WELL AS THROUGHOUT DEMOLITION AND / OR CONSTRUCTION) TO ENSURE THE FOLLOWING CONDITIONS:

- * PROPER INSTALLATION OF SAFETY FENCING AROUND ALL HAZARDOUS AREAS;
- * PROPER INSTALLATION OF SILT FENCING AROUND ENTIRE PERIMETER;
- * PROPER INSTALLATION OF PORTABLE SANITARY FACILITIES;
- * PROPER INSTALLATION OF CONSTRUCTION ACCESS WHEEL BLANKETS AND MAINTAINING THOROUGHFARES FREE OF DEBRIS;
- * CLEARANCE OF ALL MATERIAL, EQUIPMENT, ETC. WITHIN AND INSTALLATION OF SAFETY FENCING AROUND ALL TREE DRIPLINES;
- * CONSPICUOUS POSTING OF PROPERTY ADDRESS;
