FIRE PREVENTION BUREAU REQUIREMENTS

- 1.) Schedule inspection with Fire Marshal (available Saturdays):
 - ► PHONE: (201) 768-3698 / EMAIL: fireprev@closternj.us;
 - ► INSPECTION FEE: \$50.00;
- 2.) Inspection Requirements:
 - ▶ smoke detectors (1 per floor including basement and 1 within 10' of all bedrooms);
 - carbon monoxide units (1 within 10' of all bedrooms);
 - ▶ fire extinguisher (1 residential use-rated/A:B:C type not exceeding 10 lb. rating and located in kitchen area);

BUILDING DEPARTMENT REQUIREMENTS

- 1.) Submit RCCO & Lead Paint application and fee:
 - ▶ abate Zoning and Property Maintenance Violations;
 - ► finalize/close out open Construction Permits;
 - ▶ provide signature page of purchase and sale contract indicating all parties appearing on new deed (resales only);
 - ▶ provide Lead-Safe Paint Certificate issued by third party (if Borough is not performing Lead-Safe paint inspection) or Lead-Free Paint Certificate issued by third party (Lead-Safe/Lead-Free Paint Certificates are required for rental units constructed and issued Certificates of Occupancy prior to January 1, 1978);
 - ▶ "Lead-Safe" is defined as there being presence of lead paint on-site, either on interior/exterior of structures or on land, but it has been covered/stabilized via painting (determined by visual inspection and re-inspection is required every 2 years);
 - ▶ "Lead-Free" is defined as absence of lead paint on-site both on interior/exterior of structures and on land (determined by laboratory testing and Certificate is valid for life of structures);
 - RCCO INSPECTION FEE: \$100.00 for (1) dwelling unit (\$40.00 for each additional unit);
 - ▶ LEAD-SAFE PAINT INSPECTION FEE: \$220.00 per dwelling unit;
 - ► FILING FEE: \$50.00 (if Lead-Safe/Lead-Free Paint inspection is performed by third party in lieu of Borough);

- 3.) Inspection Requirements:
 - ▶ abate all hazardous or unsightly buildings, appurtenances and conditions including but not limited to Borough sidewalks, private walkways, gutters, downspouts, windows, exterior cladding, wiring, venting, surface water (discharge to/from neighboring properties), fencing/swimming pool barriers and interior/exterior handrails on stairs consisting of 3 risers or more;
 - disconnect/reroute sump pumps from Borough's sanitary sewer system (Construction Permit required);
 - ▶ remove double-key locks on primary exterior door;
 - display Borough-recognized street address as number (not in words) on front of principal building;
