2023 DOG LICENSE APPLICATION AND RABIES CLINIC

We wish to advise that renewal of your dog's license for 2023 is due and **THIS WILL BE YOUR ONLY NOTICE**. In accordance with Board of Health Ordinance #240-27 and NJ State Statutes, all dogs residing in the Borough of Closter must be licensed.

FEE: \$11.20 FOR SPAYED / NEUTERED DOG – \$14.20 IF NOT SPAYED / NEUTERED

In addition to the License Fee, there will be a **\$20.00 LATE CHARGE** if Dog's License is not renewed by **March 1, 2023**. Additionally, **SUMMONSES** will be issued if dog is not licensed by **April 1, 2023**. (NO EXCEPTIONS)

NEW JERSEY STATUTES ANNOTATED 4:19-15.2a REQUIRES THAT THE DURATION OF THE IMMUNITY AGAINST RABIES IS TO COVER THE DURATION OF THE LICENSING PERIOD, E.G, IF YOUR DOG'S RABIES VACCINATION EXPIRES 2023 YOUR PET MUST BE RE-VACCINATED BEFORE A LICENSE CAN BE ISSUED. PLEASE CONTACT THE BOARD OF HEALTH OFFICE IF YOU ARE NOT SURE WHEN YOUR DOG'S RABIES VACCINATION EXPIRES. IF YOUR DOG RECEIVED A CURRENT RABIES VACCINATION, **PLEASE SEND PROOF OF RABIES VACCINATION**.

 - A. DOGS ARE NOT PERMITTED TO RUN AT LARGE;
 - B. ADHERENCE TO LOCAL NOISE ORDINANCE (BARKING);
 - C. DOGS PROHIBITED IN FOOD ESTABLISHMENTS (EXCEPT SEEING EYE / SERVICE DOGS);
 - D. CURBING YOUR DOG
